### 1.0 PURPOSE

1.1 To establish written policies and regulations regarding the public's use of playground units (playground units are comprised of permanent recreational equipment established in designated areas of City Parks, such as swing sets, climbing apparatus and/or slides) located in various parks throughout City of Port Angeles' park system.

### 2.0 DEPARTMENT/DIVISION/PERSONNEL AFFECTED

- 2.1 Recreation Division
- 2.2 Port Angeles Police Department
- 2.3 Parks, Recreation and Beautification Commission

### 3.0 PUBLIC FACILITIES

3.1 The public facilities shall include all playground units under the management and control of the City of Port Angeles.

### 4.0 POLICY

- 4.1 Playground units have been, and will continue to be, erected in various City parks for the purpose of both recreation and to encourage the physical well being of our citizens and visitors to the community.
- 4.2 The National Playground Safety Institute Standards, followed by the Recreation Division, state that these playground units have been designed to be used by youth between the ages of two (2) and twelve (12) years and those adults supervising the children.
- 4.3 To better insure the safety and well being of the young participants, and to encourage use by appropriate age groups for which these units are designed, it shall be policy that no person of the age thirteen (13) or above be allowed to use or congregate on current, or future, playground units, unless those persons are supervising a child between the ages of two (2) and twelve (12).

### 5.0 REGULATION

- 5.1 No person of the age thirteen (13) or above be allowed to use or congregate on current, or future, playground units, unless those persons are supervising a child between the ages of two (2) and twelve (12).

### 1.0 PURPOSE

1.1 To establish written policies and regulations regarding the use of tobacco products in the general vicinity of playground units (playground units are comprised of permanent recreational equipment established in designated areas of City Parks, such as swing sets, climbing apparatus and/or slides) located in various parks throughout the City of Port Angeles' park system.

### 2.0 DEPARTMENT/DIVISION/PERSONNEL AFFECTED

- 2.1 Recreation Division
- 2.2 Port Angeles Police Department
- 2.3 Parks, Recreation and Beautification Commission

### 3.0 PUBLIC FACILITIES

3.1 The public facilities shall include all playground units under the management and control of the City of Port Angeles.

### 4.0 POLICY

- 4.1 Playground units have been, and will continue to be erected, in various City parks for the purpose of both recreation and to encourage the physical well being of our citizens and visitors to the community.
- 4.2 These playground units have been designed to be used by youth between the ages of two (2) and twelve (12) years and those adults supervising the children.
- 4.3 To better insure the health, safety and well being of the young participants for which these units are designed, it shall be policy that no person be allowed to use tobacco products within one hundred (100) feet of playground units under the management and control of the City of Port Angeles.

### 5.0 REGULATION

5.1 No person be allowed to use tobacco products within one hundred (100) feet of playground units under the management and control of the City of Port Angeles.
